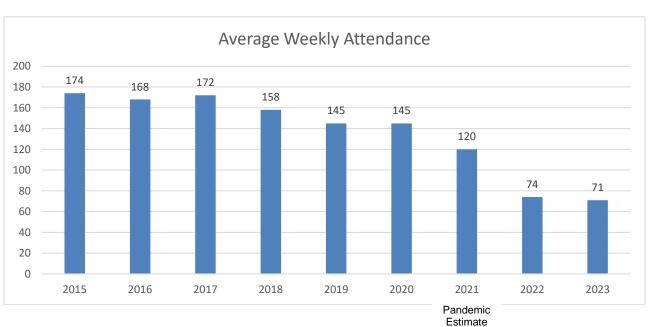

# MINUTES OF ANNUAL CONGREGATIONAL MEETING PART 1 December 10, 2023

All in person

Call to order by Council VP Janice Goodwin at 11:30 am.

Janice reviewed the purpose and agenda of meeting.

Approval of Minutes of Congregational Meeting of January 22, 2023: On motion by Bob Weiger and seconded by Ed Muraski minutes were unanimously approved.

**New Business:** Janice outlined the 3 budget options that the Council considered: conservative (do nothing and cut staff and die), moderate (seek more volunteers and cut back to income levels), or be aggressive and actively seek and fund ways to grow God's Kingdom and bring more to Jesus. Council unanimously rejected the first two options and unanimously approved the third option to "get out of the boat" and seek ways to bring more to St. John's and Jesus.

On a motion by Ed Muraski and seconded by Theresa Schultz approval of the 2024 budget moved forward and the floor was opened for discussion.

There were several questions (Cal Wood and Bob McGhie), mostly centered on missing pages for the budget presented the previous week. This was a minor oversight and Pam Glenn was able to provide copies of the full budget for those that had guestions. Sandy Brantingham pointed out that all numbers are included and listed line items that equaled the total bottom line. Nothing changed in the budget from the previous week, all line items remained the same. Wes pointed out that the bottom line is identical. Janice and Gordon reviewed the questions and highlighted once again the changes in the budget for 2024 versus 2023. Any increases were in the areas of new part-time staff or outreach efforts that Council believes could grow the church, such as multimedia and staff to support growth. One member (Tim Myer) commented that this is the most detail the congregation has been able to see, that in the past they were not able to see every line item budgeted. Another (Louise Frye) commented that this is the first time in 21 years that they feel the Council is totally transparent and does an excellent job presenting a very difficult forecast, given falling membership and post-pandemic challenges. Lois Franks commented that she believes we need more volunteers, and we shouldn't have to pay all the music assistants. She stated that she puts in countless volunteer hours and would like to see more people do so for the sake of the church. Adrienne Rule and Sandy Brantingham pointed out that some positions (childcare specifically) can't be volunteers as we have certain liability issues that we cover with paid employees.





Janice asked for a vote at which time we did paper tallies and Mike Johnson and Frank Drake double counted and presented the following to Janice for report to the congregation:

- 33 YES votes
- 3 NO votes
- 2 Abstained

40 members were signed in so we had 2 less votes than the total number of members present.

Janice reported that we have a Quorum and therefore the 2024 Budget is approved.

Adrienne Rule closed the meeting in prayer at 11:58 am.

#### **COUNCIL PRESIDENT**

Speaking for the Council, I wish to thank each and every member of this faithful congregation for their continued support, both in efforts and finances, to sustain this church. We resolve to move forward together, prayerfully listening for God's will.

As a congregation, we have experienced the joy of the celebration of the birth of Christ. We have experienced the hope of resurrection during the sunrise Easter service at Grover Beach. We have attended celebrations of life for those long-time members who have passed on to be with our Lord. On Saturdays, as part of Fun, Fitness & Fellowship, we hiked Pismo Preserve, played Disc Golf, and visited Oso Flaco Lake.

During the summer, the Council learned of a potential budget deficit. The Council passed a resolution maintaining the previously approved 2023 budget for the remainder of the year. To maintain transparency, the Council held a Congregational Forum in August to discuss the current and projected shortfall for the remainder of 2023. Following the budget forum in August, the Council began looking at what to do in 2024. During the discussion, the incident of Peter walking on the water came up (Matthew 14:22-33). The visual of Peter becoming afraid and sinking into the water is striking. We agreed that as a Council we should 'get out of the boat', to walk on the water while trusting Jesus. The congregation focusing on the 'OUT' dimension of St. John's vision statement is the way to grow the congregation. This will be both challenging and uncomfortable as we seek to fulfill this vision.

The Council appreciates the level of trust demonstrated by the congregation in their approval of the 2024 budget in December. 2024 will be a year of outreach and assessment. Anticipate a congregational meeting mid-year. The two new staff positions, Music Worship Leader and Assistant Office Manager, are each funded for six months. If the right candidate is hired soon, the Council will ask for an increase in that budgeted position to complete the calendar year.

This fall, the Council approved a working group to explore the possibility of a Christ-centered children's center, tentatively for ages 2-6 years of age. This opportunity will be explored in 2024, as the working group prudently considers issues to determine the feasibility of such a large undertaking by the congregation. The concept and funding for the project will be presented for congregational approval before any money is spent.

The Council wishes to thank Kerry Wood for her continued efforts as Financial Secretary. Please keep in mind the pledge cards that were sent out this past fall. During the stewardship drive each fall, you can reflect on your giving over the past year as one prays for God's guidance in the future.

As always, ask any Council member questions about finances. The Council strives to remain transparent with any and all issues brought before the Council.

As a church family we wish to continue the good works of St. John's for years to come. Earnest effort will be required in 2024. We look forward to working together as fellow Christians, fellow Lutherans.

#### **PROPERTY TEAM**

This church family is blessed with an amazing property. As such there is a lot of maintenance required to maintain the grounds professionally. Every 1<sup>st</sup> Saturday of the month our volunteers worked hard to keep up with trash and plant needs. Lois Franks leads our efforts with her unending care for our property. Most of the plants have been donated by her. Without her and our volunteers this property would not be so beautiful. We are thankful for their volunteer efforts, but we need more hands on a weekly basis to maintain the property. "Many hands make light work".

**Resolved in 2023:** The well issue of our neighbor was completed with a new well. The plants and drip lines were replaced by the neighbor under the direction of Lois Franks. All sprinkler lines were repaired but still require some ongoing replacements. Our irrigation system is currently being inspected and repaired as needed by Lois' repair man. Under the leadership of Janice & David Goodwin 2 pet waste stations were installed. Installation of a replacement water heater was completed.

#### **Needing Resolution:**

Our greeting sign by the office needs to be upgraded/replaced. getting bids from our sign company. Our Front Sign may be replaced by a new, larger electronic sign; Jeff Metcalfe will follow up on this project.

The Eagle Scout path project was completed. However, it crossed over several drip lines, which will require some upgrades to PVC by the Eagle Scout. DG material still needs to be removed by the Eagle Scout team.

The shed closest to the sea train needs a quote for repair of termite-damaged wood. The sea train is without power apparently due to the addition of our Solar Panels. Our main power box needs the top replaced as it has rusted and leaks, not good. Several other electrical issues exist; all currently being worked on.

Once the Warming Center is done using our facilities, we will check on the drip system that their POD was set on top of.

With the pending project of a Preschool, our property team will be involved in some potential changes to our property. This is work-in-process: most of the lawn area may be devoted to a new playground, requiring a rework of all irrigation lines. A preliminary budget is being developed for all expenses by the group researching this project.

As stated, we have a beautiful property. The hard truth is that this is being maintained by mostly 70, 80 and 90 year-old members. This team needs to begin meeting monthly in 2024 to bring in younger volunteers and have a plan for replacing those volunteers that may not be able to continue helping. - We sent urgent financial assistance to Iglesia Luterana Santa Cruz, a Hispanic church in Santa Maria, CA to provide food to families of farmworkers. Due to heavy winter storms, many were without work.

#### DRESS A GIRL AROUND THE WORLD

Like other ministries, the pandemic forced us to find new ways to keep sewing dresses and send them where they were needed. We cut our team of dress makers to only members of Saint John's because our campus was closed to outsiders at that time. Unfortunately, many of the ladies who participated felt they were being snubbed because they couldn't come on campus. The result is that our team of ladies has shrunk considerably, even though we are back to a new "normal". Our partnership with Operation Christmas Child, who was able to get out of the country during the pandemic, has grown now to four different coordinators, one locally and three others in Southern California. We have also continued to have dresses available for Zozu Project, Iglesia Luterana, China Service Ventures. We also have some new ministries - Elizabeth Anne Seton Catholic Church in Los Osos, the church of one of our sewists, is taking dresses to the Philippines, twice in 2023. One of our OCC coordinators has opened the door for us to send dresses to a ministry called Life Impact. And another group, Praying Pelican Missions, with local groups within 100-200 miles, do missionary trips to Mexico, Central America, etc. and are interested in a possible partnership with Dress A Girl. That being said, it would also mean we need more sewing people - God has a plan! This past year, we still received multiple deliveries from House of God in Redlands & Gracepoint Fellowship in Yucaipa. Along with those, our group here at Saint John's made several hundred dresses and last but not least, many of our sewists like to sew at home and bring their completed dresses in to us. In 2023, collected and sent out 1,732 dresses to different ministries who distributed them around the world! The first year we started this ministry, thanks to Greg & Cindi, we made 200 dresses that Zozu Project took in backpacks to Arua, Uganda!

It's an exciting time for us - can't wait to see what God has in mind this year!

Ethel Lenz, former board member passed on early in the year. We are thankful that Joyce joined the board earlier this year. Linda will be leaving the board in 2024. We thank her for many years of service.

All women of the church are members of Women's Ministry. The board members provide refreshments at the meetings as well as kitchen supplies, coffee supplies and cookies to serve between services. Additionally, we collect weekly funds from the basket in the Commons. All monies donated becomes the Good Samaritan Fund and is distributed by Pastor Greg to needy and hungry people. In March 2023, the featured speaker was Bonnie from the Tree of Life Pregnancy Center. Bonnie presented the various outreach projects: Counseling, emotional support, and material items for babies. The most important aspect is providing a safe and nonjudgmental atmosphere for pregnant women, both religious and secular, to share their emotions openly.

#### **Endowment Committee**

The Endowment Committee continued their stewardship of the following Endowment Funds:

The Saint John's General Fund
 1/1/2023 Balance - \$61,824.00

The Edwin & Gloria Medley Global Mission Fund 1/1/2023 Balance - \$50,551.83

• The Marty Hanson Memorial Fund 1/1/2023 Balance - \$35,616.12 **TOTAL** \$147,991.95

These funds are managed by Thrivent Charitable and are invested in a "Growth" Portfolio. designed to meet our long-term growth objectives. The goal of maintaining these Endowment Funds is to generate earnings to support ministries within Saint John's. The distribution of investment profits is limited to 5% of each fund's year-end value, if the distribution does not take the fund below its principal investment value. When these funds were originated, the following distribution protocols were established:

General Fund – 15% Youth, 20% Mission, 15% Worship & 50% Any Area Medley Fund – 100% Global Missions Hanson Fund – 100% Youth

During the first quarter of each year the Endowment Committee assesses fund performances, in accordance with the By-Laws, to determine if earnings allow for a distribution. If so, ministries are encouraged to complete a funds request to be considered by the committee. Distributions are typically made in May of that year.

Fund performances during 2022 were quite poor, taking the balances well below the threshold for distribution. Therefore, no distributions were made during fiscal 2023.

A preliminary review of 2023 fund performances shows moderate improvement, but not enough to warrant a distribution for fiscal 2023, which would have been made in early 2024.

The 2023 Endowment Committee Members were Bob Weiger – President/Treasurer, Terry Fibich, Gordon Eiland and Pastor Greg Wallace.

# Treasurer Saint John's Lutheran Church

Good news! We finished the year much better than expected. Compared to the forecast we presented during our 2024 budget meetings, offerings came in higher, expenses were lower, and investment earnings were dramatically higher. After a few late adjustments after we distributed the Giving Statements Letters, we ended the year with an operating loss of \$106,367, but our investments earned a whopping \$70,667, which reduced the net loss to \$35,700, compared to last year's net loss of \$28,396 in 2022 and our forecast of a \$99,419 loss. We even ended up beating our original budgeted loss of \$49.971. Below is a summary of our financial results for 2022 and 2023 and our approved budget for 2024:

While the loss of \$30,126 is concerning, it is much better than expected and as we noted in our last congregational meeting, we now have reserves of cash, investments, and endowments over \$1.2 million from which we can fund operating losses, if we decide to do so, as we did for the 2024 budget. During 2023 our reserves were bolstered by two remarkable gifts: \$304,000 from the Ethel Lenz Estate and \$100,000 from the Bob and Sylvia Gold estate. Below is our year-end balance sheet:

The Church Council is committed to building on the wonderful legacy left by those who sacrificed to build the church and those no longer with us. In today's world we cannot stand still. We are all called to make more disciples and grow God's kingdom on earth. The Council, with the approval of the Congregation in the 2024 budget, wishes to more aggressively, but thoughtfully and prayerfully, use a small portion of the resources we have for more outreach and efforts to grow our membership with the goal of again reaching the breakeven point. You will hear more about efforts here as the year unfolds. As Treasurer I fully support the Council's direction.

Many of you feel we should be cutting expenses. The Council continues to look for opportunities to cut costs or raise new revenue, but we do not wish to reduce the worship experience, which we feel is a key part of attracting new members.

To summarize, while we have been losing money for several years now, we have ample reserves, resources and financial strength to last a long time, even with the current losses, and even after allowing for the cost of new investments being considered such as a Christian Preschool at Saint John's and improved signage.

Following this letter is a detailed table of our income and expenses by line item for 2022 and 2023, along with our approved budgets for 2023 and the upcoming 2024 year. As discussed at the congregational budget meeting, none of the paid staff are getting cost of living increases, despite inflation. The increases in the staff payroll line item is to fund additional support for office administration (where previous cuts proved unsustainable), and new outreach efforts to grow membership, including more events, social media marketing, and a new music director position.
